

2018 Official Drawing Rules

1. The prize is a 2018 ASBO International Annual Meeting & Expo registration. Retail value of the prize is \$695. Sixteen (16) prizes will be awarded.
2. No purchase necessary to enter or win. Void where prohibited.
3. There is no limit to the number of names that may be entered in the drawing; therefore, chances of winning will vary based on the final number of names collected.
4. All entries must be submitted online by 11 p.m. EDT on Thursday, April 19, 2018.
5. The drawing is open to school business officials only. **Only one (1) entry per person is permitted.**
6. The 16 winners will be randomly selected from all eligible entries on April 20, 2018 at ASBO International.
7. The winners will have five (5) business days from April 23, 2018 to communicate with ASBO International if they accept the drawing prize; otherwise, ASBO International will draw a new name. Prize winners will be registered by ASBO International and will receive a “complimentary” registration to the 2018 Annual Meeting & Expo.
